

**Automated Red Light Enforcement (ARLE)
Transportation Enhancements Grant Program**
Pennsylvania Department of Transportation

Approximately \$8 million is available for eligible projects, including, but not limited to, roadway safety, mobility, and capacity upgrades; bicycle and pedestrian improvements; Local Technical Assistance Program (LTAP) projects; and traffic signal improvements.

- Eligibility:** Local governments, planning organizations, and Commonwealth agencies
- Award Amount:** No minimum or maximum stated
- Required Match:** None required
- Applications Due:** *July 1, 2020*

York and Lancaster Counties Habitat Improvement Grant Program
Pennsylvania Fish and Boat Commission (PFBC)

Funds are available for habitat improvement and/or sediment reduction projects implemented in York or Lancaster County, including stream improvement projects, agricultural best management practices, and small dam removal projects.

- Award Amount:** \$100,000 annually (\$75,000 maximum per project)
- Required Match:** None stated

COVID-19 Emergency Supplement to the General Appropriation Act of 2019

Funds are available for COVID-19 relief to small businesses to cover operating expenses for the duration of the shutdown and the transition period to reopening, technical assistance for business owners as they stabilize and relaunch their businesses, debt payment relief, and loan loss reserves.
